We are seeking to appoint a suitably qualified, committed and enthusiastic Media and Performing Arts Technician to join the Media and Performing Arts (MPA)Technician Team. The successful candidate will be managed by the MPA Technician Manager and be joining a vibrant college community which is open, friendly, and supportive. As a college, we are ambitious for our students, and we are seeking to appoint staff who can bring the right blend of skill, flexibility, commitment and energy.

Contract details:

- Permanent, 42 weeks per year (Term Time Only plus 16 days to be worked in the holidays)
- 18.5 hours per week Monday to Friday (between 8am and 4pm, flexible)
- The pro-rata salary is £11,918 per annum (based on Grade 4, spine point 11 in the Support Staff Pay Spine for which full-time salary is £26,097 per annum).
- 5.5 weeks holiday pay included in pro rata salary
- Salary will increase annually within Grade 4 over 4 years.

Media and Performing Arts Technician Team

The MPA technician team are friendly and creative. They support and encourage each other to achieve high standards and the best possible outcomes for the people they work with. The team works with staff and students from a range of courses in the Media and Film, and the Performing Arts Departments. The successful candidate will be involved in supporting the practical work of students taking subjects within these areas, with a focus on Performing Arts. Responsibilities will include liaising with students and teachers to determine their technical requirements, editing and compiling music, sound effects and video for performances and setting up and operating lighting and sound systems for rehearsals and performances, both during the College day and evenings where required. The technician will also be required to perform general day to day technical support to classes as required and to assist other members of the MPA Technician team where necessary, during activities such as Music concerts and showcase events.

Please note that due to the nature of this role, flexibility with regards to working pattern is required. If there are specific days and times that you would not be available, then please let us know in the covering letter.

JOB DESCRIPTION

MAIN RESPONSIBILITIES:

The technician will be primarily responsible for supporting the practical work in Media & Performing Arts, with a primary focus on the Performing Arts courses and working with the other MPA Technicians when required.

SPECIAL CONDITIONS:

Although most work is within the normal College working day, the post involves a requirement to support student practical work in late afternoon, twilight and evening sessions (including some weekends).

Candidates are requested to indicate their availability to work throughout the week upon application.

SPECIFIC DUTIES:

- 1. Practical support for staff and students in all Performing Arts disciplines during class work, small performances (some off-site), rehearsals, examinations and shows
- 2. Some evening/weekend technical support of student productions and practical work, with prior notice given (currently around 25 evenings, up to 5 of which are at the weekend)
- 3. Support students and staff with technical aspects of their work, assisting teachers through 1:1 or group demonstrations and advice
- 4. Manage the technical aspects of productions and practical work.
- 5. Maintain resource levels and troubleshoot technical problems to ensure learning areas are suitably equipped for each session and the equipment is ready for use, is safe and functional
- 6. Assist with set construction, creative design and rigging of theatre lighting and sound.
- 7. Produce and maintain technical documentation and online guide material for staff and students
- 8. Liaise with technical suppliers to arrange equipment hires and piano tuning etc and order materials and resources, check deliveries and maintain an accurate inventory
- 9. Keep working areas clean, clear and safe and assist in the maintenance of the Health & Safety aspects of the area; including risk assessments, information sheets and notices, practical advice sheets, accident and incident records etc and offer advice to staff and students on Health & Safety matters when necessary
- 10. Work together with the other MPA Technicians to help with the setup and running of shared projects
- 11. Be able to use multi-media and music software such as Adobe Creative Cloud Suite and Apple Logic Pro and support staff and students with this software when necessary.
- 12. Other duties of a technical nature related to work in this area, or work in other areas of the college, including assisting other MPA technicians when required
